**COST:** The field trip is free and includes a free lunch provided at the Eastern Michigan University.

**DEADLINE FOR PERMISSION SLIP:** Permission slips must be turned into Wainwright, Lansing Catholic, Quentin Park or Letts site directors by Wednesday, July 11, 2018, in order to go to Eastern Michigan University. In case of rain on Wednesday, field trip forms may be dropped off at Foster Community Center, 2<sup>nd</sup> Floor or at sites for 15 minutes at 9 am and 12 noon.

**FIELD TRIP RULES:**

1. *Each child must have a signed field trip permission slip from a parent/guardian before going on the trip.*
2. Participants must ride the bus to the field trip location and return home on the bus. No participant will be released to a relative or friend they may meet at the field trip location without written parental permission.
3. Participants must obey the rules set by Lansing Parks and Recreation and the Todd Martin Youth Leadership Program Directors. If any participant refuses to cooperate or is disruptive, the parents may be called to pick their child up at the field trip location and may not be allowed to attend future field trips. Lansing Parks and Recreation and the Todd Martin Youth Leadership Program Directors reserve the right to deny any child or adult eligibility to participate in any activity if any of the above rules are violated.
